# **License to Carry Firearms Application and Procedure**

**Application Process:** Applicants are required to call the Dudley Police Department to have their name added to the Firearms Appointment list. You will need to leave your best daytime phone number to be reached at and the date your current license expires. If you are not currently licensed please specify this will be a new application. Please call 508-9423-4417.

On the date and time of your interview have a seat in the lobby of the Dudley Police Department. You will be called in when it is your turn. You will be subject to being fingerprinted and photographed. Yous should have the following documents with you:

- 1. A firearms license application. (Be sure to fill out completely and honestly)
- 2. A Massachusetts driver's license or ID card with a Town of Dudley address.
- 3. A \$100.00 non-refundable check made out to the Town of Dudley. <u>Cash and credit cards NOT</u> accepted.
- 4. New applicants must provide a copy of their Firearms Safety Certificate issued by the Commonwealth if Massachusetts. Applicants renewing should bring their most recent firearms license.

Applicants will be issued a dated receipt to confirm their application. A background investigation and determination of suitability will be conducted on all applicants. If your permit is denied, you will be notified by the licensing authority in writing as to the reason for the denial. Failing to answer the questions honestly is a reason for the denial of your application.

Applicants renewing their license should start the process 90 days before the expiration date. There is a 90 day grace period for expired licenses but only if you have your interview and possess your receipt.

**Change of Address:** If you are moving, you, must file a change of address form within 30 days. This form must be given to the issuing license authority, the licensing authority to the town you are moving to, and to the Firearms Records Bureau. Failure to notify shall be cause for the suspension of your firearms license.

# **Important Information**

## Please read this entire Document Carefully

**IF YOUR APPLICATION IS DENIED** it is usually due to: Disqualifying criminal record, false answer to any question on the application or to any question asked by the licensing officer during the interview, criminal record information omitted from or not attached to the application, as required. As a result of enacting then Massachusetts Gun Control Act of 1998, for the purposes of firearms licensing, any and all previous detentions, arrests, court appearances, convictions, juvenile adjudications (including any "Sealed" records) will be accessed and considered in order to determine if there is statutory disqualifier or to determine the "suitability" of all applicants for a license to carry and possess firearms. After reading this form you will be asked some very specific questions regarding personal background, past criminal offenses, history, etc. You must answer all questions fully and truthfully, *failure to do so will result in your application being denied*.

## In addition:

QUESTION #4 on page 2 of the license asks, "Have you ever been arrested or appeared in court as a defendant for any criminal offense?" A key word here is "appeared", not necessarily convicted. You do not have to list non-criminal traffic offenses. Having been arrested, charged, convicted, or adjudicated delinquent of a crime doesn't necessarily prohibit you from getting a license to carry firearms or an FID card. Failure to disclose the required information will result in a denial.

Please not that "ever appeared" includes all *adult* and *juvenile* court appearances. It does not matter if you were found not guilty or not delinquent or if the charges were dismissed or if the case was continued without a finding, etc. You have to disclose ALL arrests and court appearances. If you do not answer all questions truthfully, we will find out, no matter how long ago the incident may have occurred. If you have a sealed record you must disclose that. You do not have to disclose what the offenses were. When doing record checks were will also receive sealed record data in order to determine if the offenses are disqualifiers or if nay would affect an applicant's suitability.

If your application is denied we will not accept any excuse, such as "I forgot about it", "I thought it was dismissed", "I was told it wouldn't show up", "It never showed up before" or "It was so long ago I didn't think it mattered now", etc.

Make any necessary corrections before submitting your application. If necessary, you can contact the Massachusetts Criminal History Systems Board at www.ma.gov/chsb to learn how you may obtain your own Massachusetts criminal record history, before you submit your application. If there is any omission or any false answer discovered, your application will be denied, and you may face criminal prosecution.
